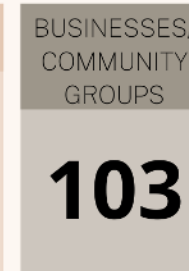
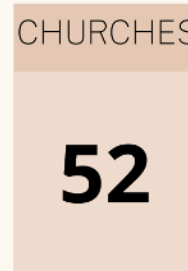
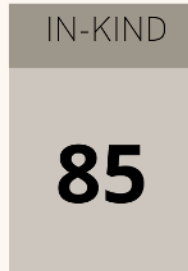

Residential Treatment:

Placing Agencies Served:

- Dubois County DCS: 3 (8%)
- Knox County DCS: 1 (3%)
- Posey County DCS: 2 (5%)
- Sullivan DCS: 1 (3%)
- Vanderburgh County DCS: 3 (8%)
- Vanderburgh County Probation: 26 (72%)

Served a total of 36 youth

- 20 females
- 16 males

Average number of days in placement= 148
Range of service was from 11 to 878 days.

Day Education:

Placing Agencies Served:

- Dubois County DCS: 1 (4%)
- Vanderburgh County Probation: 22(96%)

Served a total of 23 youth

- 10 females
- 13 males

9 youth earned High School Equivalency, a graduation rate of 75%! All 9 youth passed on the first try!

- Average time for youth to prep and pass the test: 7.6 months
- 11 of the 23 youth spent some time in the Residential Treatment Program while attending Day Education.

- Vanderburgh County Probation: 32 (31%)

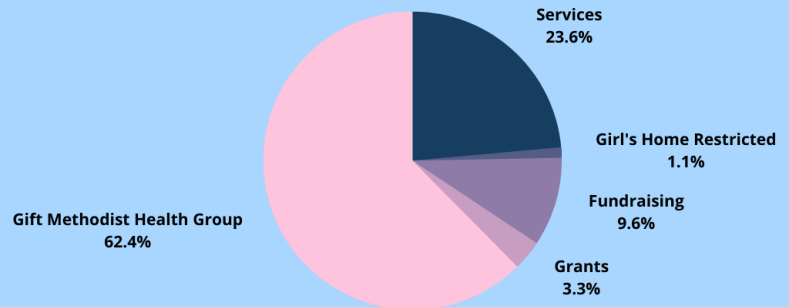
Served a total of 103 youth

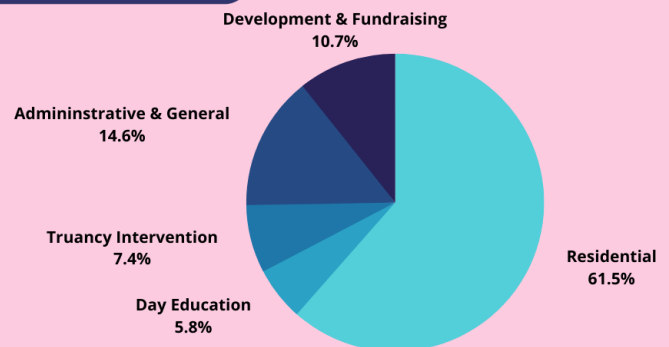
2021 INCOME
